2. Discuss and consider an employment review of the City Manager, pursuant to A.R.S. § 38-431.03(A)(1).

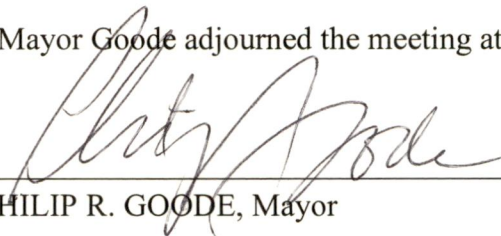
At 12:39 pm Mayor Goode reconvened Open Session.

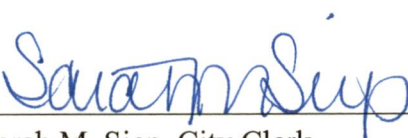
