MINUTES

1. CALL TO ORDER

Chairman Gjede called the meeting to order at 2:00 p.m.

2. ROLL CALL

3. DISCUSSION & ACTION ITEMS

A. Approval of Minutes from May 19, 2026 Airport Advisory Committee Meeting.

**MOTION BY MEMBER NORTHRUP TO APPROVE MAY 19, 2026 MINUTES;
SECONDED BY MEMBER ADAMS: (6-0)**

B. Presentation & Discussion Regarding Potential Privatization of Transportation Security Administration.

Representatives from the American Federation of Government Employees (AFGE) presented concerns about the potential privatization of Transportation Security Administration (TSA) being promoted to smaller commercial service airports across the country.

- AFGE reported that 4 of 9 Arizona airports they have spoken with oppose TSA privatization.
- TSA Gold+ was discussed as a model that would allow private companies to participate in security operations, using advanced AI technology, potentially reducing the role of human judgment.
- AFGE raised concerns that privatization could negatively impact both PRC and TSA by lowering wages and weakening standards and regulations currently upheld under federal management.

Member Northrup clarified that the presenters were representing AFGE, not TSA as an institution. Mr. Crider confirmed with the AFGE members that the purpose of the visit was to gather preliminary feedback from Arizona airports before formal proposals or recommendations are considered.

C. Presentation & Discussion Regarding Updates Related to Airport Administration and Airport Area Activity.

Airport Services Manager Christina Stapleton presented updates on airport activity, including operations, delays, load factors, and administrative items for the past month and year-to-date

- **Operations:** Increased 12% over the prior year

Flight Delays:

- **May:**
 - LAX: 4 maintenance, 1 crew rest
 - DEN: 5 ATCT ground delay program (in DEN), 1 maintenance, 2 late turns, 1 station/customer service(passenger required aisle chair assistance), 2 weight/balance, 1 fueling (pilot requested additional fuel)

Load Factors:

- **May:**
 - LAX: 73.0% (2025: 65.8%)
 - DEN: 70.8% (2025: 80.2%)
- **June:**
 - LAX – 57.7% (2025 – 54.3 %)
 - DEN – 61.5% (2025 – 66.4%)

The Committee discussed airline delays associated with weather, disabled aircraft, maintenance issues, and load factors related to the Denver route.

This item was for discussion only, no formal action was taken.

D. Presentation & Discussion Regarding Airport Construction Projects and Updates.

Airport Capital Projects Manager John Kuebrich provided updates on Airport Construction Projects:

Completed Projects:

- South Ramp Crack Seal / Sealcoat
- South Hangars Ramp Crack Seal / Sealcoat
- Southwest Ramp Spot Repairs
- Restriping and Signage at Old Terminal

Projects Under Design:

- ARFF / SRE Operations Facility
 - Eligibility plan review currently underway
 - Project will be done in two Phases, site preparation tentatively to begin January 2027.
- North Ramp Reconstruction
 - Design efforts have resumed.
- Northeast Ramp
 - Currently under contract with Dibble. A stakeholder meeting is planned for June.
- Southwest Ramp
 - Design is anticipated to begin after July 1. Staff is currently working to finalize a contract with Mead & Hunt.
- Vehicle Service Road (VSR)
 - Scope and contract negotiations are underway with Mead & Hunt.
- Additional Overflow Parking
 - Along Janine Drive
 - Includes Demo of Quonset Hut
 - Pedestrian Walkway to Terminal
 - Design is under Contract.
- Rental Car Staging and Prep Area
 - At SR89 & McCurdy
 - Includes Demo of Quonset Hut

Upcoming Design Projects:

- Hangar Development Program Phase 1
 - Includes Wash Rack
 - Advertising June 21st & June 28th
 - Bids Due August 6th
 - Engineer's Estimate is \$3,450,000
- Taxiway Foxtrot Realignment
 - Phase One Construction
 - Advertising July 5 & July 12th
 - Bids Due August 27th

- Engineer's Estimate is \$2,200,000

The Committee discussed the proposed rental car vehicle staging and preparation area planned for the South side of Highway 89. Members also reviewed progress on the new Air Traffic Control Tower project, and the status of the runway extension project.

E. Presentation & Discussion Regarding Airport Operations.

Airport Operations Manager Julia Metivier provided operational updates, including:

- Fire season operations are underway and Taxiway "H" closures will remain in effect through July 31. The future Northeast Ramp project is expected to help mitigate these closures.
- **Cutter Aviation Hot Fueling** – Approximately 4 since April 8th
- **Ramp name changes become effective July 9, 2026**
 - South Ramp --> Leighnor Ramp & South Hangar Ramp
 - Guidance Ramp --> Southwest Ramp
 - SAFE Ramp --> Eagle North Ramp
 - RITTAIRE Ramp --> Eagle Multi Ramp
 - Riddle Ramp --> Eagle Main Ramp
 - West Ramp --> Northwest Ramp
 - Monarch --> Juliet Tango Ramp
- **Protocol for Emergency Response & Aircraft Removal**
 - Clear the closed runway as soon as possible and re-open
- **Security Incidents**
 - Incidents occurred regarding leaving a gate unattended or open. Reviewed the rules on gate etiquette.
- **Drone Incidents**
 - Covered the procedure that should be followed when observing a drone
 - Attempt to identify the following information:

Location of the UAS in proximity to airport

- Registration Number or description of UAS as applicable
- Identification or description of pilot(s) and number of persons
- Associated motor vehicles and the license number, or any distinguishing marks.
- Purpose of threat
- Contact the PRC Air Traffic Control Tower

- Keep UAS and pilot(s) under surveillance until TSA, Police, or ATCT is contacted, if possible.
